用途

该试剂盒用于体外定量检测人血清、血浆或其它相关生物液体中IgG4浓度。

检测原理

本试剂盒采用竞争 ELISA 法。用人 IgG4 抗原包被于酶标板上,实验时样品(或标准品)中的人 IgG4 与包被的人 IgG4 竞争生物素标记的抗人 IgG4 单抗上的结合位点,游离的成分被洗去。加入辣根过氧化物酶标记的亲和素,生物素与亲和素特异性结合而形成免疫复合物,游离的成分被洗去。加入显色底物(TMB), TMB 在辣根过氧化物酶的催化下呈现蓝色, 加终止液后变成黄色。用酶标仪在 450 nm 波长处测 OD 值,IgG4 浓度与 OD450 值之间呈反比,通过绘制标准曲线计算出样品中 IgG4 的浓度。

说明:浓缩HRP酶结合物(100×)和底物溶液(TMB)请避光保存。

所有试剂瓶盖须旋紧以防止蒸发和微生物的污染。

试剂体积以实际发货版说明书为准。相关试剂在分装时会比标签上标明的体积稍多一些, 请在使用时量取而非直接倒出。

试验所需自备物品

- 1. 酶标仪(450 nm波长滤光片)
- 2. 高精度移液器, EP管及一次性吸头: 0.5-10μL, 2-20μL, 20-200μL, 200-1000μL
- 3.37℃恒温箱
- 4. 双蒸水或去离子水
- 5. 吸水纸
- 6. 加样槽

样品收集方法

- 血清: 全血样品于室温放置1小时或2-8℃过夜后于2-8℃, 1000×g离心20分钟, 取上清即可检测。
- 血浆: 抗凝剂推荐使用EDTA-Na₂, 样品采集后30分钟内于2-8℃, 1000×g离 心15分钟,取上清即可检测。
- 3. 组织匀浆:用预冷的PBS (0.01M, pH=7.4)冲洗组织,去除残留血液,称重后将组织剪碎。将剪碎的组织与对应体积的PBS(一般按1:9的重量体积比,比如1 g的组织样品对应9 mL的PBS,具体体积可根据实验需要适当调整,并做好记录。推荐在PBS中加入蛋白酶抑制剂)加入玻璃匀浆器中,在冰上充分研磨。为了进一步裂解组织细胞,可以对匀浆液进行反复冻融或超声破碎。最后将匀浆液于2-8℃,5000×g离心5-10分钟,取上清检测。
- 4. 细胞提取液: 贴壁细胞用冷的PBS轻轻清洗,然后用胰蛋白酶消化,1000×g 离心5分钟后收集细胞;悬浮细胞可直接离心收集。收集的细胞用冷的PBS 洗涤3次。每10⁶个细胞中加入150-200 μL PBS重悬(推荐在PBS中加入蛋白酶 抑制剂;若含量很低可减少PBS的体积)并通过反复冻融或超声使细胞破碎。 将提取液于2-8℃,1500×g离心10分钟,取上清检测。
- 5. 细胞培养上清或其他生物体液: 收集液体后于2-8℃, 1000×g离心20分钟,除去杂质及细胞碎片。取上清检测。

样本处理相关试剂推荐: PMSF蛋白酶抑制剂 (货号: <u>E-EL-SR002</u>)、0.25% 胰蛋白酶溶液 (货号: <u>EP-CM-L0043</u>)。

注意事项

■ 试剂盒注意事项

- 1) 本试剂盒仅供体外研究使用, 不用于临床诊断。
- 2) 试验中请穿着实验服并戴乳胶手套做好防护工作。特别是检测血液或者其他体液样品时,请按国家生物试验室安全防护条例执行。
- 3) 刚开启的酶标板孔中可能会有少许水样物质,此为正常现象,不会对实验结果造成任何影响。暂时不用的板条应拆卸后放入备用铝箔袋,按照上述表格中保存条件存放。
- 4) 请勿重复使用已稀释过的标准品、生物素化抗体工作液、酶结合物工作液。未用完的浓缩生物素化抗体(100×)、浓缩HRP酶结合物(100×)、酶标板及其他原液按照上述表格中保存条件存放。
- 5) 检测使用的酶标仪需要安装能检测450±2 nm波长的滤光片,光密度范围在0-3.5之间。建议使用时提前15分钟预热。
- 6) 请勿使用其他批号或其他来源的试剂混合或替代本试剂盒中的试剂。
- 7) 试验中所用的EP管和吸头均为一次性使用, 严禁混用。
- 8) 请勿使用过期的试剂。

■ 样品注意事项

- 1) 收集血液的试管应为一次性无内毒素试管。避免使用溶血,高血脂样品。
- 2) 样品收集后若在1周内进行检测可保存于2-8℃,若不能及时检测,请按一次使用量分装,冻存于-20℃(1个月内检测),或-80℃(3个月内检测),避免反复冻融。在检测前,冷冻过的样本应缓慢地融化并离心除去冻融过程产生的沉淀物。室温混匀后使用。
- 3) 试剂盒检测范围不等同于样本中待测物的浓度范围。如果样品中待测物浓度过高或过低,请对样本做适当的稀释或浓缩。
- 4) 若所捡样本不在说明书所列样本之中,建议做预实验验证其检测有效性。
- 5) 若使用化学裂解液制备组织匀浆或细胞提取液,由于引入某些化学物质会导致FLISA测值出现偏差。
- 6) 某些重组蛋白可能与试剂盒中捕获或检测抗体不匹配而出现不能检测的情况。

样本稀释方案

正常血清/血浆样本推荐稀释 200~400 倍检测。

由于存在个体差异,请提前预估样本的浓度范围,并通过预实验确定待检样本的稀释倍数。

如果您的检测样本需要稀释, 通用稀释方案参考如下:

稀释 100 倍:一步稀释。取 5 μL 样本到 495 μL 标准品&样本稀释液内,做 100 倍 稀释·

稀释 1000 倍: 两步稀释。取 5 μL 样本到 95 μL 标准品&样本稀释液内,做 20 倍稀释,再取 5 μL 20 倍稀释样本到 245 μL 标准品&样本稀释液内,做 50 倍稀释,总共稀释 1000 倍:

稀释 100000 倍: 三步稀释。取 5 μ L 样本到 195 μ L 标准品&样本稀释液内,做 40 倍稀释,再取 5 μ L 40 倍稀释样本到 245 μ L 标准品&样本稀释液内,做 50 倍稀释,最后取 5 μ L 2000 倍稀释样本到 245 μ L 标准品&样本稀释液内,做 50 倍稀释,总 共稀释 100000 倍;

每步稀释时取液量不少于 3 μL, 稀释倍数不超过 100 倍。每步稀释都需混合均匀, 避免起泡。


检测前准备工作

- 提前20分钟从冰箱中取出试剂盒,平衡至室温(18-25℃)。如果试剂盒需分 多次使用,请仅取出本次实验所需的酶标板条和试剂,剩余板条和试剂需 按照指定条件保存。
- 2. 洗涤液:将浓缩洗涤液用双蒸水稀释(1:24)。提示:从冰箱中取出的浓缩洗涤液可能有结晶,属于正常现象,可用40℃水浴微加热使结晶完全溶解后再配制洗涤液。当日使用。
- 3. 标准品工作液:将标准品于10000 xg离心1分钟,加入标准品&样品稀释液1 mL至冻干标准品中,旋紧管盖,静置10分钟,上下颠倒数次,待其充分溶解后,轻轻混匀,避免起泡,配成40 μg/mL的标准品工作液(或加入1 mL标准品&样品稀释液后,静置1-2分钟,用低速涡旋仪充分混匀。可通过低速离心去除涡旋过程中产生的气泡)。然后根据需要进行倍比稀释。建议配制成以下浓度:40、20、10、5、2.5、1.25、0.63、0 μg/mL。

倍比稀释方法:取7支EP管,每管中加入500μL标准品&样品稀释液,从40μg/mL的标准品工作液中吸取500μL到第一支EP管中混匀配成20μg/mL的标准品工作液,按此步骤往后依次吸取混匀。如下页图示。提示:最后一管直接作为空白孔,不需要再从倒数第二管中吸取液体。

复溶后的40 μg/mL标准品工作液分装后放置-20℃保存,请在半个月内使用完,避免反复冻融。

倍比稀释的标准品工作液需要现配现用。



- 4. 生物素化抗体工作液:实验前计算当次实验所需用量(以50 μL/孔计算),实际配制时应多配制100-200 μL。使用前15分钟,将浓缩生物素化抗体于800×g离心1分钟,以生物素化抗体稀释液将100×浓缩生物素化抗体稀释成1×工作浓度(例如:10 μL浓缩液+990 μL稀释液)。现配现用。
- 5. HRP酶结合物工作液: HRP酶结合物为HRP酶结合亲和素。实验前计算当次实验所需用量(以100 μL/孔计算),实际配制时应多配制100-200 μL。使用前15分钟,将浓缩HRP酶结合物于800×g离心1分钟,以酶结合物稀释液将100×浓缩HRP酶结合物稀释成1×工作浓度(例如: 10 μL浓缩液+990 μL稀释液)。现配现用。

操作步骤

- 1. 分别设定标准孔、空白孔和样本孔。标准孔加入 50 μL 倍比稀释的标准品,空白孔加入 50 μL 标准品&样本稀释液,其余孔加入 50 μL 待测样本(建议所有的待检样本和标准品在检测中设立复孔;建议通过预实验或咨询技术支持确定待检样本的稀释倍数)。立即每孔加入配好的生物素化抗体工作液 50 μL。给酶标板覆膜,37℃孵育 45 分钟。提示:加样时将样品加于酶标板底部,尽量不触及孔壁,轻轻晃动混匀,避免产生气泡。加样时间宜控制在 10 分钟内。
- 2. 甩尽孔內液体,在洁净的吸水纸上拍干。每孔加洗涤液 350 μL,浸泡 1分钟,吸去或甩掉酶标板內的液体,拍干。重复此洗板步骤 3 次。提示:此处与其他洗板步骤都可使用洗板机(参考北京拓普 DEM-3 型洗板机参数设置:2点吸,每孔加入洗涤液 350 μL,振板 5 秒,吸液 0.5 秒)。洗板完成后请立即进行下步操作,不要让微孔板干燥。
- 3. 每孔加 **HRP 酶结合物工作液** 100 μL, 酶标板加上覆膜, 37℃温育 30 分钟。

- 4. 甩尽孔内液体, 洗板 5次, 方法同步骤 2。
- 5. 每孔加底物溶液(TMB) 90 μL, 酶标板加上覆膜, 37℃避光孵育 15 分钟左右。提示:根据实际显色情况酌情缩短或延长,但不可超过 30 分钟。当标准孔出现明显梯度时(前 4 个显色孔出现明显蓝色梯度),即可终止。提前 15 分钟打开酶标仪预热。
- 每孔加**终止液** 50 μL,终止反应。提示:终止液的加入顺序应尽量与底物溶液的加入顺序相同。
- 7. 立即用酶标仪在 450 nm 波长测量各孔的光密度(OD 值)。

结果判断

- 计算标准品和样本复孔的平均OD值,以浓度为横坐标,OD值为纵坐标,在 双对数坐标轴上拟合四参数逻辑函数的标准曲线。
- 若样品OD值低于标准曲线下限,应适当稀释后重测并在计算样本浓度时乘以相应的稀释倍数。

Intended use

This ELISA kit applies to the in vitro quantitative determination of Human IgG4 concentrations in serum, plasma and other biological fluids.

Test principle

This ELISA kit uses the Competitive-ELISA principle. The micro ELISA plate provided in this kit has been pre-coated with Human IgG4. During the reaction, Human IgG4 in samples or Standard competes with a fixed amount of Human IgG4 on the solid phase supporter for sites on the Biotinylated Detection Ab specific to Human IgG4. Excess conjugate and unbound sample or standard are washed from the plate, and Avidin conjugated to Horseradish Peroxidase (HRP) are added to each microplate well and incubated. Then a TMB substrate solution is added to each well. The enzyme-substrate reaction is terminated by the addition of stop solution and the color change is measured spectrophotometrically at a wavelength of 450 ± 2 nm. The concentration of Human IgG4 in the samples is then determined by comparing the OD of the samples to the standard curve.

Kit components & Storage

An unopened kit can be stored at $2-8^{\circ}$ C for 12 months. After opening, store the items separately according to the following conditions.

Sample collection

Serum: Allow samples to clot for 1 hour at room temperature or overnight at $2-8^{\circ}$ C before centrifugation for 20 min at $1000 \times g$ at $2-8^{\circ}$ C. Collect the supernatant to carry out the assay. **Plasma:** Collect plasma using EDTA-Na₂ as an anticoagulant. Centrifuge samples for 15 min at $1000 \times g$ at $2-8^{\circ}$ C within 30 min of collection. Collect the supernatant to carry out the assay.

Tissue homogenates: It is recommended to get detailed references from the literature before analyzing different tissue types. For general information, hemolyzed blood may affect the results, so the tissues should be minced into small pieces and rinsed in ice-cold PBS (0.01M, pH=7.4) to remove excess blood thoroughly. Tissue pieces should be weighed and then homogenized in PBS (tissue weight (g): PBS (mL) volume=1:9) with a glass homogenizer on ice. To further break down the cells, you can sonicate the suspension with an ultrasonic cell disrupter or subject it to freeze-thaw cycles. The homogenates are then centrifuged for 5-10 min at $5000 \times g$ at $2-8 \,^{\circ}$ C to get the supernatant. **Cell lysates:** For adherent cells, gently wash the cells with moderate amount of pre-cooled PBS and dissociate the cells using trypsin. Collect the cell suspension into a centrifuge tube and centrifuge for 5 min at $1000 \times g$. Discard the medium and wash the cells 3 times with pre-cooled PBS. For each 1×10^6 cells, add $150-250 \mu L$ of pre-cooled PBS to keep the cells suspended. Repeat the freeze-thaw process several times or use an ultrasonic cell disrupter until the cells are fully lysed. Centrifuge for 10 min at $1500 \times g$ at $2-8 \,^{\circ}$ C. Remove the cell fragments, collect the supernatant to carry out the assay.

Cell culture supernatant or other biological fluids: Centrifuge samples for 20 min at $1000 \times g$ at $2-8 \,^{\circ}$ C. Collect the supernatant to carry out the assay.

Recommended reagents for sample preparation: PMSF Protease Inhibitor (Cat No. E-EL-SR002), 0.25% Trypsin Solution (Cat No. E-EL-SR001).

- 4) Do not reuse the reconstituted standard, biotinylated detection Ab working solution, HRP conjugate working solution. The unspent undiluted concentrated biotinylated detection Ab (100×) and other stock solutions should be stored according to the storage conditions in the above table.
- 5) The microplate reader should be able to be installed with a filter that can detect the wave length at 450±2 nm. The optical density should be within 0-3.5. Follow the Instructions of the Microplate Reader for set-up and preheat it for 15 min before OD measurement.
- 6) Do not mix or substitute reagents with those from other lots or sources.
- Change pipette tips in between adding of each standard level, between sample adding and between reagent adding. Also, use separate reservoirs for each reagent.
- 8) The kit should not be used beyond the expiration date on the kit label.

■ Note for sample

- Tubes for blood collection should be disposable and be non-endotoxin. Samples with high hemolysis or much lipid are not suitable for ELISA assay.
- 2) Samples should be assayed within 7 days when stored at 2-8°C, otherwise samples must be divided up and stored at -20°C (≤1 month) or -80°C (≤3 months). Avoid repeated freeze-thaw cycles. Prior to assay, the frozen samples should be slowly thawed and centrifuged to remove precipitates.
- 3) Please predict the concentration before assaying. If the sample concentration is not within the range of the standard curve, users must determine the optimal sample dilutions for their particular experiments.
- If the sample type is not included in the manual, a preliminary experiment is suggested to verify the validity.
- 5) If a lysis buffer is used to prepare tissue homogenates or cell lysates, there is a possibility of causing a deviation due to the introduced chemical substance.
- Some recombinant protein may not be detected due to a mismatching with the coated antibody or detection antibody.

Dilution method

It is suggested to dilute normal mouse serum/plasma samples at 200~400 fold.

Due to individual differences, please estimate the concentration range of the sample in advance, and conduct a preliminary test to determine the appropriate dilution ratio of the sample.

If your test sample needs dilution, please refer to the dilution method as follows:

For 100 fold dilution: One-step dilution. Add 5 μL sample to 495 μL sample diluent to yield 100 fold dilution.

For 1000 fold dilution: Two-step dilution. Add 5 μ L sample to 95 μ L sample diluent to yield 20 fold dilution, then add 5 μ L 20 fold diluted sample to 245 μ L sample diluent, after this, the neat sample has been diluted at 1000 fold successfully.

For 100000 fold dilution: Three-step dilution. Add 5 μ L sample to 195 μ L sample diluent to yield 40 fold dilution, then add 5 μ L 40 fold diluted sample to 245 μ L sample diluent to yield 50 fold dilution, and finally add 5 μ L 2000 fold diluted sample to 245 μ L sample diluent, after this, the neat sample has been diluted at 100000 fold successfully.

Reagent preparation


- Bring all reagents to room temperature (18-25°C) before use. If the kit will not be used
 up in one assay, please only take out the necessary strips and reagents for present
 experiment, and store the remaining strips and reagents at required condition.
- Wash Buffer: Dilute 30 mL of Concentrated Wash Buffer with 720 mL of deionized
 or distilled water to prepare 750 mL of Wash Buffer. Note: if crystals have formed in
 the concentrate, warm it in a 40°C water bath and mix it gently until the crystals have
 completely dissolved.
- 3. **Standard working solution:** Centrifuge the standard at 10,000×g for 1 min. Add 1 mL of Reference Standard &Sample Diluent, let it stand for 10 min and invert it gently several times. After it dissolves fully, mix it thoroughly with a pipette. This reconstitution produces a working solution of 40 μg/mL (or add 1 mL of Reference Standard &Sample Diluent, let it stand for 1-2 min and then mix it thoroughly with a vortex meter of low speed. Bubbles generated during vortex could be removed by centrifuging at a relatively low speed). Then make serial dilutions as needed. The recommended dilution gradient is as follows: 40、20、10、5、2.5、1.25、0.63、0 μg/mL.

Dilution method: Take 7 EP tubes, add 500 μ L of Reference Standard & Sample Diluent to each tube. Pipette 500 μ L of the 40 μ g/mL working solution to the first tube and mix up to produce a 20 μ g/mL working solution. Pipette 500 μ L of the solution from the former tube into the latter one according to this step. The illustration on the

next page is for reference. Note: the last tube is regarded as a blank. Don't pipette solution into it from the former tube.

The working solution of the standard substance at $40 \mu g/mL$ after reconstitution should be aliquoted and stored at -20 °C. It should be used up within half a month and repeated freeze-thaw should be avoided.

Gradient diluted standard working solution should be prepared just before use.



- 4. Biotinylated Detection Ab working solution: Calculate the required amount before the experiment (50 μL/well). In preparation, slightly more than calculated should be prepared. Centrifuge the Concentrated Biotinylated Detection Ab at 800×g for 1 min, then dilute the 100×Concentrated Biotinylated Detection Ab to 1× working solution with Biotinylated Detection Ab Diluent (Concentrated Biotinylated Detection Ab: Biotinylated Detection Ab Diluent= 1: 99). The working solution should be prepared just before use.
- 5. HRP Conjugate working solution: HRP Conjugate is HRP conjugated avidin. Calculate the required amount before the experiment (100 μL/well). In preparation, slightly more than calculated should be prepared. Centrifuge the Concentrated HRP Conjugate at 800×g for 1 min, then dilute the 100×Concentrated HRP Conjugate to 1× working solution with HRP Conjugate Diluent (Concentrated HRP Conjugate: HRP Conjugate Diluent= 1: 99). The working solution should be prepared just before use.

Assay procedure

- 1. Determine wells for diluted standard, blank and sample. Add 50 μL each dilution of standard, blank and sample into the appropriate wells (It is recommended that all samples and standards be assayed in duplicate. It is recommended to determine the dilution ratio of samples through preliminary experiments or technical support recommendations). Immediately add 50 μL of Biotinylated Detection Ab working solution to each well. Cover the plate with the sealer provided in the kit. Incubate for 45 min at 37°C. Note: solutions should be added to the bottom of the micro ELISA plate well, avoid touching the inside wall and causing foaming as much as possible.
- 2. Decant the solution from each well, add 350 μL of wash buffer to each well. Soak for 1 min and aspirate or decant the solution from each well and pat it dry against clean absorbent paper. Repeat this wash step 3 times. Note: a microplate washer can be used in this step and other wash steps. Make the tested strips in use immediately after the wash step. Do not allow wells to be dry.
- Add 100 μL of HRP Conjugate working solution to each well. Cover the plate with a new sealer. Incubate for 30 min at 37 °C.
- Decant the solution from each well, repeat the wash process for 5 times as conducted in step 2.
- 5. Add 90 μ L of **Substrate Reagent** to each well. Cover the plate with a new sealer. Incubate for about 15 min at 37 °C. Protect the plate from light. Note: the reaction time can be shortened or extended according to the actual color change, but not more than 30 min. Preheat the Microplate Reader for about 15 min before OD measurement.
- Add 50 μL of Stop Solution to each well. Note: adding the stop solution should be done in the same order as the substrate solution.
- Determine the optical density (OD value) of each well at once with a micro-plate reader set to 450 nm.

Assay Procedure Summary



Biotin

1. Add 50µL standard or sample to the wells, immediately add 50µL Biotinylated Detection Ab working solution to each well. Incubate for 45 min at 37°C



2. Aspirate and wash the plate for 3 times



3. Add $100\mu L$ HRP conjugate working solution. Incubate for 30 min at $37^{\circ}C$. Aspirate and wash the plate for 5 times



4. Add 90µL Substrate Reagent. Incubate for 15 min at 37°C



5. Add 50µL Stop Solution



6. Read the plate at 450nm immediately. Calculation of the results

Calculation of results

Average the duplicate readings for each standard and samples. Plot a four parameter logistic curve on log-log axis, with standard concentration on the x-axis and OD values on the y-axis.

If the OD of the sample under the lowest limit of the standard curve, you should re-test it with an appropriate dilution. The actual concentration is the calculated concentration multiplied by the dilution factor.

■ Precision

Intra-assay Precision (Precision within an assay): 3 samples with low, mid range and high level Human IgG4 were tested 20 times on one plate, respectively.

Inter-assay Precision (Precision between assays): 3 samples with low, mid range and high level Human IgG4 were tested on 3 different plates, 20 replicates in each plate, respectively.
