## SECTION 4 FIRST-AID MEASURES

### 4.1 General advice

Consult a physician. Show this safety data sheet to the doctor in attendance.

### 4.2 If inhaled

If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

### 5.1 Suitable extinguishing media

Suitable: Water spray, alcohol-resistant foam, dry chemical, carbon dioxide or appropriate foam.

For small fires, use media such as "alcohol" foam, dry chemical or carbon dioxide.

For large fires, apply water from as far as possible. Use large quantities of water applied as a mist or spray. Solid streams of water may be ineffective. Cool affected containers with flooding quantities of water.

### 5.2 Special precautions for fire-fighters

Protective Equipment: Wear self-contained breathing apparatus and protective clothing to prevent contact with skin and eyes.

### 5.3 Special hazards arising from the substance or mixture

Carbon oxides, Nitrogen oxides (NO<sub>x</sub>), Sulphur oxides, Hydrogen chloride gas.

## SECTION 6 ACCIDENTAL RELEASE MEASURES

### 6.1 Person-related safety precautions

Use personal protective equipment. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Beware of vapors accumulating to form explosive concentrations. Vapors can

accumulate in low areas.

### 6.2 Measures for environmental protection

Prevent further leakage or spillage if safe to do so. Do not let enter drains. Discharge into the environment must be avoided.

### 6.3 Measures for containment and cleaning

Contain spillage, and then collect with non-combustible absorbent material (eg. sand, diatomaceous earth, vermiculite).

Place in a container for disposal according to local regulations. Pick up and arrange disposal without creating dust. Sweep up and shovel. Keep in suitable, closed containers for disposal. Sweep up and shovel.
