SECTION 4 FIRST-AID MEASURES

4.1 General advice

Consult a physician. Show this safety data sheet to the doctor in attendance.

4.2 If inhaled

SECTION 6 ACCIDENTAL RELEASE MEASURES

6.1 Person-related safety precautions
