## **SECTION 5 FIRE FIGHTING MEASURES**

#### 5.1 Suitable extinguishing media

Suitable: Water spray, alcohol-resistant foam, dry chemical, carbon dioxide or appropriate foam.

## 6.1 Person-related safety precautions
